

TERMS AND CONDITIONS FOR THE PROMOTION "FORMIDABLE ÚNICA"

1.- ORGANISING COMPANIES

ENDESA ENERGÍA, S.A.U., with Tax ID No. A-81948077, and ENDESA X SERVICIOS, S.L.U., with Tax ID No. B-01788041, both with registered office at Calle Ribera del Loira, 60, Post Code 28042, Madrid, (hereinafter the "*Organisers*"), are the organisers of this promotion, called "FORMIDABLE ÚNICA" (hereinafter "*Promotion*"), which will be governed by these legal terms and conditions (hereinafter "*Legal Terms and Conditions*"), which will be made available and kept up to date on www.endesa.com/es/promociones-ganadores and www.endesaxstore.com/es/es/informacion-legal/condiciones-generales-de-contratacion-de-cada-producto

This Promotion is just one of those organised within the same Campaign called FORMIDABLE ENDESA.

2.- OBJECTIVES OF THE PROMOTION

By granting discounts, the objective of the Promotion is to encourage new contracts with the Organisers of the following: The ENDESA ENERGÍA ÚNICA tariff (electricity and/or gas) and where applicable, the ENDESA X SERVICIOS Hogar Plus maintenance service.

Supply contracts (electricity and/or gas) are made with ENDESA ENERGÍA and in this regard, "*new contracts*" are considered to be those that are made for supply points that had not previously contracted the ÚNICA tariff.

The contract for the Hogar Plus maintenance service, if applicable, is made with ENDESA X SERVICIOS. Hogar Plus may only be contracted if you have contracted the ENDESA ENERGÍA ÚNICA tariff.

3.- RATES / SERVICE THAT FALL WITHIN THE PROMOTION

From ENDESA ENERGÍA:

- Electricity: The corresponding discount may only be applied to contracts made for electricity supply points that have a 2.0TD access tariff (maximum contracted power of 10kW) and that contract the ÚNICA tariff.
- Gas: The corresponding discount may only be applied to contracts made for gas supply points with access tariff RL.1, RL.2 and RL.3 and that contract the ÚNICA tariff.

From ENDESA X SERVICIOS:

- Home Plus maintenance service, for electricity and/or gas.

4.- VALIDITY PERIOD

The duration of the Promotion (hereinafter, the "Term") will be from February 5, 2024 to March 31, 2024, including both full days. Without prejudice to the prerogative of the Organisers to shorten or extend the Term.

5.- TERRITORIAL SCOPE

This Promotion will be valid for supply points or addresses located in the national territory excluding Ceuta and Melilla.

6.- PARTICIPANTS

Insofar as the discounts for this Promotion are applicable to contracts made with the Organisers and which remain in force, the individuals who, at any time, hold the status of holders of such contracts shall be considered Participants.

7.- DISCOUNT

7.1 - FORMIDABLE ÚNICA discount table

When making a new contract in accordance with these Legal Terms and Conditions, a percentage discount will be applied to the ÚNICA quota as indicated in the following table (hereinafter, "*FORMIDABLE ÚNICA discount table*"), in accordance with the status achieved with the new contract:

7.2 - Activation of the discount

The corresponding discount will be activated from the time the new contract that enabled its provision comes into force.

7.3 - Duration of the discount

The discount lasts for up to two (2) years from its activation.

7.4 - Modification of the discount

If, for whatever reason, the contracting status changes from one type of status to another of those indicated in the FORMIDABLE ÚNICA Discount Table, the applicable discount will also be modified accordingly.

For example, in accordance with the FORMIDABLE ÚNICA Discount Table, if a customer changes from a type E contract (gas supply + Hogar Plus) to a type B contract (gas supply only), then the discount on the ÚNICA quota changes from 23% to 20%.

7.5 - Loss of the discount

The discount will be forfeited if all contracts are no longer in force.

8. PUBLISHING AND ACCEPTING THE LEGAL TERMS AND CONDITIONS

These Terms and Conditions are governed by Spanish law and both the Participants and the Organisers expressly submit to the jurisdiction and competence of the Courts of the capital city of Madrid for the resolution of any dispute that may arise regarding the interpretation and/or application of these Terms and Conditions, notwithstanding any other jurisdiction to which they may be entitled by law.

10.- TAXATION

The prices applied in invoices will be subject to the tax regulations currently in force and applicable at the time they accrue.

11.- PROCESSING OF PERSONAL DATA

Taking into account that, in order to participate in this Promotion, the interested parties should contract the ENDESA ENERGÍA ÚNICA tariff, and where applicable, ENDESA X SERVICIOS services, Participants' Personal Data will be processed in accordance with the provisions of the data protection clause in the general terms and conditions in the respective contract(s). Furthermore, should the interested parties contract the ENDESA X SERVICIOS Hogar Plus service together with the ENDESA ENERGÍA ÚNICA tariff, the

Organisers will exchange the necessary identification details in order to be able to apply the discounts established in these Terms and Conditions.
