

LEGAL TERMS AND CONDITIONS "20% discount on gas for 1 year"

1. ORGANISER

Endesa Energía, S.A.U. (hereinafter "the Organiser"), with registered office at Calle Ribera del Loira 60, 28042 Madrid, and Tax ID A81948077, is organising a **"20% discount on gas for 1 year"** promotion, hereinafter "the Promotion"), which will be governed by the following legal terms and conditions (hereinafter "the Legal Terms and Conditions") which will be available on www.endesa.com/es/promociones-ganadores.

2. AIM OF THE PROMOTION

The objective of the Promotion is to incentivise during the Validity of the Promotion new contracts with Endesa Energía for gas tariffs, for RL.1, RL.2 and RL.3 supplies.

3. PERIOD OF VALIDITY

The period for participating in the Promotion (hereinafter, the "Period of Validity") will begin on 6 November 2023 at 00:01 (Spanish mainland time) and will end on 4 February 2024 at 23:59 (Spanish mainland time).

4. TERRITORIAL SCOPE

This Promotion will be valid for supply points located in the Spanish territory, excluding Ceuta and Melilla.

5. LEGAL BASIS TO PARTICIPATE

The Promotion is aimed at any natural person over 18 years of age or legal entity that already has an electricity contract with Endesa Energía at the time of contracting gas or makes a new gas supply contract simultaneously with the electricity contract through Endesa Energía as the retailer and at any of the tariffs specified below. A new contract is a contract that comes from any retailer other than Endesa Energía, as well as new contracts signed directly with Endesa Energía.

The Promotion includes the following Endesa Energía tariffs:

- Endesa Gas
- One Gas

The holders of the new contracts are the "Participants" of this Promotion.

6. DEPOSIT AND ACCESSIBILITY

7. INCENTIVES

A 20% discount on the variable term for gas during the first year will be offered, from the date the contract is signed.

8.- ACCEPTANCE OF THE LEGAL TERMS AND CONDITIONS

By participating in the Promotion, the Participant accepts the Legal Terms and Conditions. The Participant accepts that the Organiser may postpone, shorten, extend, modify, cancel or suspend the Promotion if necessary, without this implying any liability for the Organiser, which will notify such changes as soon as possible on the website: www.endesa.com/es/promociones-ganadores

The Organiser is authorised to resolve any unforeseen contingency in these Legal Terms and Conditions, and to interpret it, without prejudice to the provisions in these Terms and Conditions in case of dispute.

9. APPLICABLE LAW AND JURISDICTION

These terms and conditions are governed by Spanish law and both the Participants and the Organiser expressly submit to the jurisdiction and competence of the Courts of the city of Madrid for the resolution of any dispute that may arise regarding the interpretation and/or application of these Terms and Conditions, notwithstanding any other jurisdiction to which they may be entitled by law.

10. TAXES

The prices applied in bills will be subject to the tax regulations currently in force and applicable at the time they accrue.

11. PROCESSING PERSONAL DATA

Taking into account that, in order to participate in this Promotion, the interested parties must sign up for one of the Endesa Energía services indicated above, Participants' Personal Data shall be processed in accordance with the provisions in the data protection clause of the general conditions in their contract.
