

**LEGAL TERMS AND CONDITIONS AND DATA PROTECTION POLICY FOR THE
PROMOTION: "The Response 2022"**

1. ORGANISER

Endesa Energía, S.A.U. (hereinafter "The Organiser" or "Endesa Energía"), with address at Calle Ribera del Loira 60, 28042 Madrid, and Tax ID A81948077, is the organiser of the "The Response 2022" promotion (hereinafter "the Promotion"), which will be governed by the following legal terms and conditions (hereinafter, "the Legal Terms and Conditions"), which are available on www.endesa.com/es/promociones-ganadores

2. OBJECTIVE OF THE PROMOTION

The objective of the Promotion during the Period of Validity is to encourage new contracts with Endesa Energía for electricity tariffs for supplies with access tariff 2.0 TD (contracted power up to 15kW), except in the case of the unregulated tariff for which only supplies with access tariff 2.0TD (contracted power up to 10kW) will be offered.

3. PERIOD OF VALIDITY

The period for participation in the Promotion (hereinafter, the "Validity Period") will begin on 14 June 2022 at 12.01am (Spanish mainland time) and will end on 18 October 2022 at 08.00am (Spanish mainland time).

4. TERRITORIAL SCOPE

This Promotion will be valid for supply points located in Spanish territory excluding Ceuta and Melilla.

5.- THOSE QUALIFIED TO PARTICIPATE

The Promotion is aimed at any natural person of 18 years of age and over, or any legal person that arranges a new contract for electricity and/or gas with Endesa Energía. A new contract shall be understood to mean any contract from a commercial outlet other than Endesa Energía in any part of Spain, as well those registered directly.

Contracts formalised during the Period of Validity for any of the following electricity and gas tariffs with Endesa Energía are included in the Promotion:

Unregulated Tariff, Tempo Happy Tariff, One Tariff (only 1 and 3 time bands)

6.- DEPOSIT AND ACCESSIBILITY

The Legal Terms and Conditions will be published and accessible to all Participants and the general public on: www.endesa.com/es/promociones-ganadores.

7.- INCENTIVES

A discount of 20% is offered on the basic price for the energy term during the first year from the date of activation of the contract, providing it is for one of the following Endesa Energía electricity tariffs:

Unregulated Tariff, Tempo Happy Tariff, One Tariff (only 1 and 3 time bands).

Furthermore, from the second year, after the first twelve months from the date of activation of the contract, a 10% discount on the basic price for the energy term will be applied indefinitely, for the same tariffs mentioned above.

8. HOW THE PROMOTION WORKS

All the Participants who wish to benefit from this incentive offered by the Promotion should take out a new contract with Endesa Energía, and during the Period of Validity for the Promotion, take out a new electricity contract with one of the tariffs indicated in section

5.

9. ACCEPTANCE OF THE LEGAL TERMS AND CONDITIONS

By participating in the Promotion, the Participant accepts the Legal Terms and Conditions. The Participant accepts that the Organiser may postpone, shorten, extend, modify, cancel or suspend the Promotion if necessary, without this implying any liability for the Organiser, which will notify such changes as soon as possible on the website: www.endesa.com/es/promociones-ganadores.

The Organiser is authorised to resolve any unforeseen contingency in these Legal Terms and Conditions, and to interpret it, without prejudice to the provisions in these Terms and Conditions in case of dispute.

10.- APPLICABLE LAW AND JURISDICTION

These terms and conditions are governed by Spanish law and both the Participants and the Organiser expressly submit to the jurisdiction and competence of the Courts of the city of Madrid for the resolution of any dispute that may arise regarding the

interpretation and/or application of these Terms and Conditions, notwithstanding any other jurisdiction to which they may be entitled by law.

11.- TAX ISSUES.

The prices applied in bills will be subject to the tax regulations currently in force and applicable at the time they accrue.

12.- PROCESSING PERSONAL DATA

Taking into account that, in order to participate in this Promotion, the interested parties need to contract one of the Endesa services indicated above, the processing of the Participants' Personal Data will be undertaken in accordance with the provisions in the data protection clause of the general conditions in their contract.
